SOLICITATION FOR INPUT ON CASE OF THE YEAR COMPETITION (COY)

The COY competition has always been an opportunity for our students to receive recognition for their excellence in preparing their reports. The Executive Committee is soliciting your feedback to improve the competition. It is our goal to improve some elements for this year's competition, and any major changes will be announced this year for implementation in next year's competition.

If you wish to offer suggestions as to how the competition should be held, we would appreciate your input. We need your comments by **May 31, 2004**. As we will classify your input into a topical area, it would help if you could put your suggestion into this topical area as you submit it.

We will do our best to include all opinions, but we know that some opinions are diametrically opposed. Our intent is to increase the number of participants, provide a fair and equitable process, and make the awards rewarding to our students, directors, and stakeholders. If your idea does not fit into a category, please use the final "Other" category and define the issue as well as your suggestion. Thank you for your participation.

Category 1 Standards

The criteria for excellence do not seem to represent the true value we are trying to provide the business and our students. What are we trying to achieve and how can we measure it?

- Criteria
- Priorities

Category 2 Categories for Judging

Graduate Comprehensive (two or more major functional areas)

- Graduate Specialized (specific topic to comprehensive analysis of one functional area)
- Undergraduate Comprehensive (see above)
- Undergraduate Specialized (see above)
- Other

Rookie (first submission within 4 years unless prior national 1st or 2nd place award ever won)

Community Development or Economic Development (some studies are not for specific businesses)

Category 3 Judges

There have been criticisms regarding the ethics of judging our own projects as we might not objectively evaluate cases impartially based on the criteria, etc.

Potential Sources for Judges—SCORE; Business Leaders; Consultants; SBDCs; SIFE; NFIB; YEO (Denver based consultants or something like this)—other

- Procedures for selection
- Procedures for judging

Category 4 Methodology

There have been some discussions about the efficacy of continuing the district structure for competition. Some have suggested we move away from district competition and have a national competition with more awards—such as first, second, third and honorable mention if the case achieves an established minimum level of quality. Many universities would regard an honorable mention at the national level ahead of a district win for example. Also, the competition within districts is uneven, and changes over time as the SBIA membership changes. Another area of discussion involves the number of categories and number of awards a single university can win.

Category 5 Awards

This category involves the actual process of giving the awards. Early notification to allow more student participation at the National Conference, more recognition for award sponsors such as SIFE, other.

Category 6 Timing

Since our conference will be held with USASBE for the next few years at least, the national SBI conference and the presentation of the awards will be one month earlier. If we do not have district competitions, we could still hold to the current submission deadline in August. If we decide to continue the district competitions, the date for submission will have to be moved up.

Category 7 Process Issues

There has always been the issue of to what extent did the students actually do the report. Should the process certify that the students did the report with the oversight of their professor, and did not receive help from consultants, graduate assistants, or other professors directly in the writing of the report. Actual phrasing of this and what to include to make this statement complete is open to suggestion.

Category 8 Enforcement

There needs to be a mechanism in place to impose penalties or disqualification in situations of violation of the rules. Suggestions?

Certified Small Business Counselor Program (CSBC)

The CSBC was approved by the SBI Association in 1999, and is administered by the VP for Quality Assurance. CSBC is good for a 4 year period.

The Certified Small Business Counselor program is designed to raise the standards of its members, enhance performance of Small Business Institute® Directors and Case Supervisors, and recognize those who have reached a higher level of knowledge within the small business counseling field. The CSBC Counselor program has these main goals:

- 1) To create a common body of knowledge and standards of performance for small business counselors
- 2) To enhance the professionalism of SBI members/small business counselors
- 3) To offer members a self-directed venue for taking an active role in their own professional development

In brief, the SBI Association awards Professional Development Units (PDUs) for learning experiences that increase the skills and abilities of participants. Participants

accumulate 50 PDUs from six required categories during the 4-year certification period, as follows:

- at least 8 PDUs from the category of Conferences and Workshops;
- at least 3 PDU's from the category of Field Case Supervision and/or Small Business Consulting;
- at least 4 PDUs from the category of Professional Membership;
- at least 6 PDUs from the category of Professional Development;
- and at least 2 PDUs from either the category of Presentations OR Publications/Articles.

The first class of CSBCs was awarded certification at our national conference in 2001. This is a reminder to all original CSBC counselors that 2004 is their renewal year and if they wish to be renewed, they need to submit the CSBC information, per our website.
